Steve Cruse Show Horses agrees to perform the services contemplated by this agreement, subject to the following:

1. \$300.00 booking fee (part of the breeding fee) is due with this agreement and the balance of breeding fee plus all unpaid expenses (including, but not limited to, veterinary, farrier, and board) shall be paid as billed, but no later than immediately prior to mare leaving the ranch. All re-breeds for the following breeding season will be charged a \$300.00 booking fee.
2. Mare shall be in a healthy and sound breeding condition. Mare Owner understands that all barren mares have a clean uterine culture prior to breeding, either completed before mare enters the ranch or at the ranch prior to breeding, but at owner's expense. Mares should be wormed within 60 days of entering the ranch, and should be vaccinated for **tetanus, influenza, encephalitis, rhinopneumonitis and intranasal strangles.**
3. The mare's vaccination for rhinopneumonitis shall be current within one (1) year, and a booster rhinopneumonitis shall be administered according to the drug manufacturer's instructions as the mare progresses through her pregnancy. Failure to vaccinate as required by the drug manufacturer shall void the live foal guarantee, as hereafter provided.

4. Proof of a negative Coggins test, taken within 12 months shall accompany the mare entering the ranch. A copy of the mare's registration papers – *including the back* – shall also be required at the time of entry, *and must include a vet health certificate, uterine culture, and deworming certificates*. If any of the required tests do not accompany the mare at time of entry, then Steve Cruse Show Horses will cause the test and/or vaccination to be performed at the owner's expense.
5. Unless otherwise agreed, the end of the breeding season is June 15th. In this connection, Steve Cruse Show Horses agrees to act diligently to settle the mare but shall not be responsible if a mare does not settle.
6. A live foal is guaranteed from this mating. Should the foal not stand and nurse, the mare owner will be entitled to return privileges the following breeding season. However, the breeding fee that has previously been paid is not returnable, in addition to payment for all expenses. The return service in the next breeding season is not transferable to another party. Upon the loss of a foal, the breeding ranch shall receive a statement from the attending veterinarian which include the vaccination dates of the bred mare, and shall state that the mare did not produce a live foal. It is further agreed that, should the above stallion die or become unfit for service during this season or the season immediately following the one in which the original breeding fee has been paid, and the mare does not have a live foal, the breeding fee will be returned as long as the Mare Owner is entitled to return privileges as stated above. If the mare dies or becomes unfit to breed, another mare may be substituted with the stallion owner's consent. Breeder's certificates are issued after notification that the foal is born.
7. It is understood that neither the Stallion Owner, Steve Cruse Show Horses, employees, guests, or veterinarian will be responsible for accident, sickness or death of a stallion, mare, and/or foal. Steve Cruse Show Horses shall exercise its best judgment in the care and supervision of the stallion, mare, and/or foal and shall not be liable for death, injury, or sickness of stallion, mare, and/or foal.
8. The breeding season for the purposes of this contract shall begin February 1st and close June 15th for the year of the contract.
9. Mare Owner agrees to the following expenses...
  - Board per day (check preferred board)

**SHIPPED SEMEN**

Please notify us 24 hours prior to shipment or by 8:00 am Central Time the day of shipment. If you require semen on Sunday, please order it by 8:00 am Central Time on Friday.

- A. Stallion Service Fee **\$1,000.00**.
- B. A non-refundable booking fee of **\$300.00** due at signing and acceptance of this contract. Balance of **\$700.00** due on or before first shipment.
- C. An additional deposit of **\$175.00** will be necessary for the following...
  - 1. Semen collection and packaging fee (**\$175.00** for first shipment; **\$175.00** per shipment thereafter)
  - 2. Reservations for transported semen
- D. Steve Cruse Show Horses, upon receipt of the above mentioned stallion fee, confirms the breeding to the Stallion selected on Page 1 of this contract for the present breeding season.
- E. All requests for semen shipments shall be filled as received subject to availability of the Stallion selected on page 1 of this contract semen and the approval of Steve Cruse Show Horses. If there is insufficient semen to fill all orders on a given day, Steve Cruse Show Horses will determine which orders will be honored. This decision will be based on information provided by the attending veterinarian.
- F. Airmail fees to be paid at Mare Owner's expense. - **Airport Courier Fee: \$75.00**  
FedEx shipping fees to be paid at Mare Owner's expense.
